

## **Planners Quiz Campaign 2021 Official Rules**

The Planners Quiz Campaign 2021 (“promotion”) is hosted by Experience Sioux Falls (“administrator”). **The promotion is open to Qualified Meeting Professionals (“participants”) who are legal residents in the 50 United States, are at least 21 years of age, have a physical business address in the United States and is the meeting planner or decision maker for their organization with the authority to book a meeting in Sioux Falls, South Dakota. Venue meeting professionals do not qualify. Limited to one person per company at the discretion of Experience Sioux Falls.** This promotion is governed by US law and is subject to all applicable federal, state and local laws and regulations. Employees of Experience Sioux Falls and parent companies, affiliates, subsidiaries, advertising, promotion and fulfillment agencies and members of the immediate family or household of each are not eligible to participate. The promotion features one \$50 Visa Pre-Paid Gift Card that will be awarded to a random qualified participant monthly over the course of five months. The number of entries does not increase the chances of winning. Participants will be asked to provide specific information in order to be eligible to win. Participants’ information will be available upon request after September 30, 2021. Once participants have finished the registration process and completed the quiz at [ExperienceSiouxFalls.com/Quiz](https://ExperienceSiouxFalls.com/Quiz), they will be officially entered. All entries become the property of Experience Sioux Falls and will not be returned.

The administrator and each of their respective shareholders, employees, parents, directors, officers, affiliates, representatives, agents, successors, and each of their related companies, agencies, distributors, sponsors and all prize suppliers/participants are not responsible for lost, damaged, stolen, late or misdirected entries, and all such entries are ineligible. Multiple entries will be accepted, but it does not increase your chances of winning. Participants will be asked to provide first name, last name, organization/business, title, and email address. A total of five winners (one winner monthly) will be randomly selected from the qualified pool of entries by the administrator at the end of each month from May 2021 – September 2021.

- Participant must be the meeting planner or decision maker with the authority to book a meeting in Sioux Falls, South Dakota. Venue meeting professionals do not qualify.
- Participants will be further qualified by Experience Sioux Falls.
