

## **Planners Sioux Falls Sourced Box 2021-22 Sweepstakes Official Rules**

The following sweepstakes is intended for viewing in the 50 United States and shall only be construed and evaluated according to United States law. No purchase necessary. Void where prohibited by law. Participation constitutes entrant's full agreement and acceptance to these rules.

The Planners Sioux Falls Sourced box promotion ("sweepstakes") is hosted by Experience Sioux Falls (formerly the Sioux Falls Convention & Visitors Bureau) ("administrator"). **The sweepstakes is open to Qualified Meeting Professionals ("participants") who are legal residents in the 50 United States, are at least 21 years of age, have a physical business address in the United States and is the meeting planner or decision maker for their organization with the authority to book a meeting in Sioux Falls, South Dakota. Venue meeting professionals do not qualify. Limited to one person per company at the discretion of Experience Sioux Falls.** This promotion is governed by US law and is subject to all applicable federal, state and local laws and regulations.
